## What is the purpose of this update?

This document tells you how the Simplicity Balanced Investment Fund (Balanced Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

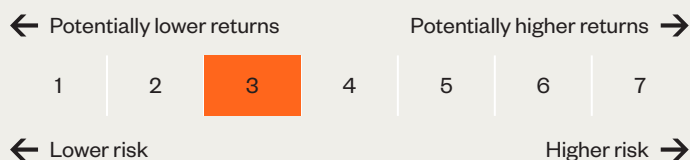
The Balanced Fund provides investors with an exposure to a mix of growth and income assets. As a result, the return from the Fund is likely to be lower over the longer term (10 years or more) than the Growth Fund, but the value of its investments is likely to fluctuate more than the Conservative Fund.

## What are the risks of investing?

Risk indicator for the Balanced Fund<sup>1</sup>:

### Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## Example of how this applies to an investor

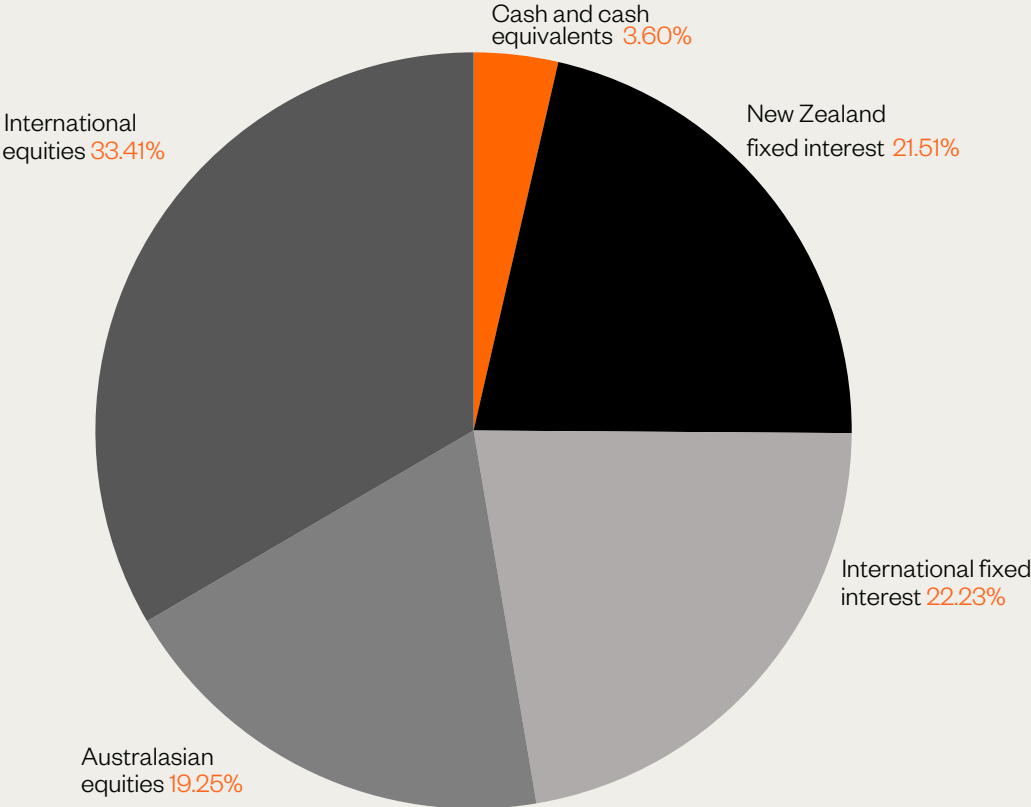
Small differences in fees and charges can have a big impact on your investment over the long term.

Ben had \$10,000 in the fund when the fund started on 3 April 2017 and did not make any further contributions. At 30 September 2017, Ben received a return after fund charges were deducted of \$242 (that is 2.42% of his initial \$10,000). Ben also paid \$15 in other charges. This gives Ben a total return after tax of \$227 for the period.
