Description of this fund

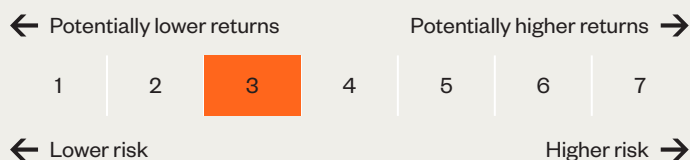
The NZ Bond Fund invests in New Zealand government bonds and investment grade, liquid bonds issued in New Zealand dollars, designed to be the New Zealand bond component of a diversified investment portfolio.

Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

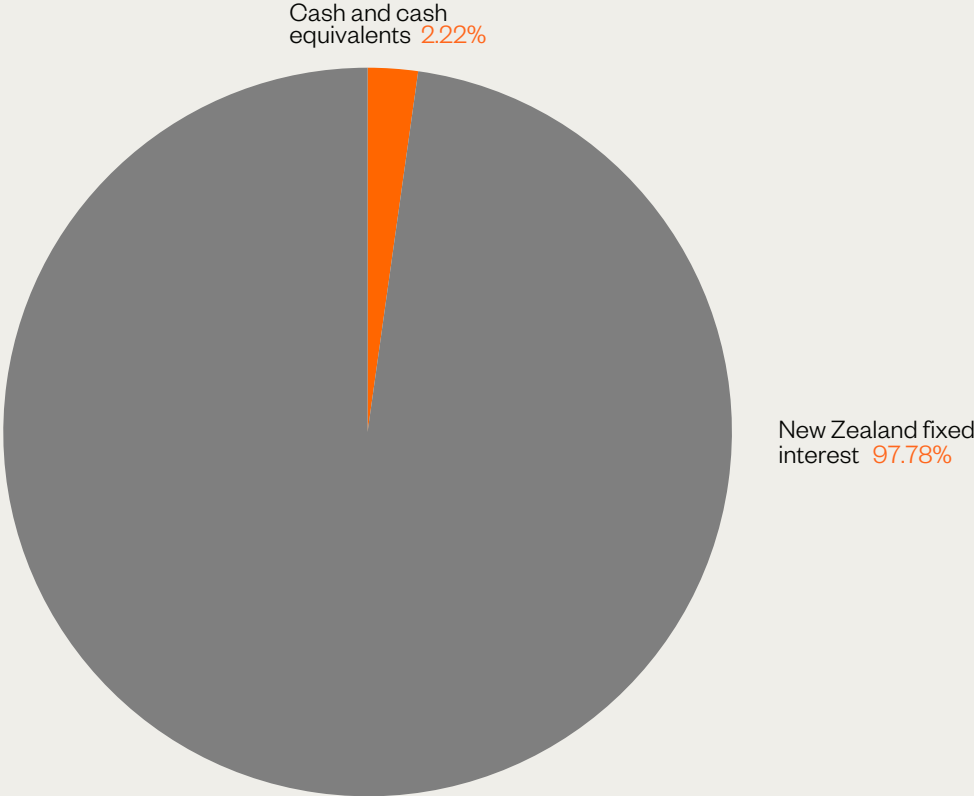
Small differences in fees and charges can have a big impact on your investment over the long term.

Ben had \$10,000 in the fund when the fund started on 3 April 2018 and did not make any further contributions. At 30 June 2018, Ben received a return after fund charges were deducted of \$82 (that is 0.82% of his initial \$10,000). Ben also paid \$7.50 in other charges. This gives Ben a total return after tax of \$74.50 for the period.
